Said costs shall include all personnel time and court costs incurred by the City of Paso Robles to procure any judicial writ or inspection warrant.

Application is made to the Paso Robles Department of Emergency Services for inspection and approval of the described operation or activity which must conform to all applicable standards. No operation or activity requiring a permit will be performed until a permit is received. We understand working without approved plans and a permit will result in delays and additional fees.

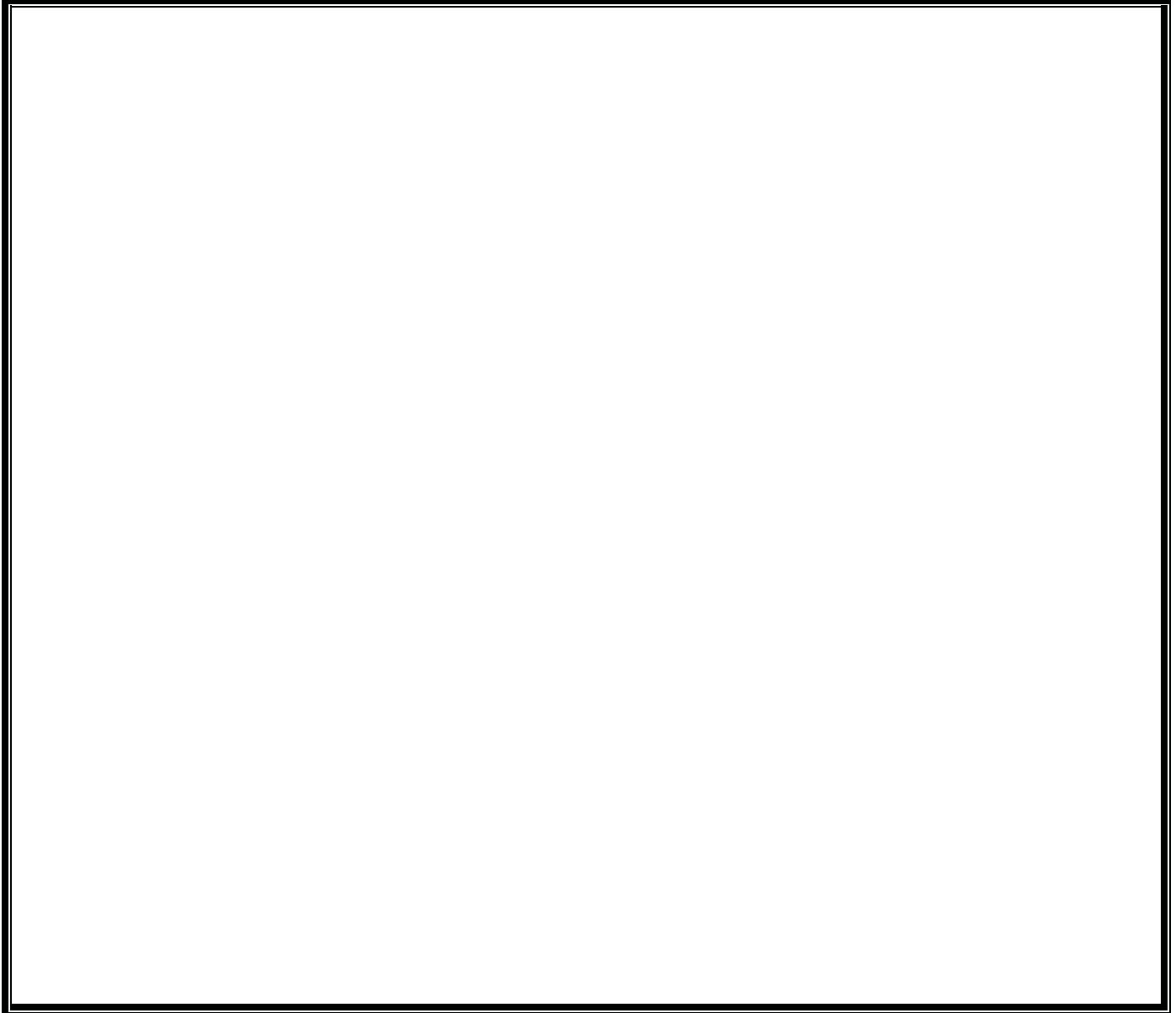
