### **Toilet Rebate Program Terms and Conditions**

The City of Paso Robles is offering rebates of up to \$125 to homeowners or business owners who replace a high flow toilet (3.5 gallon flush or higher) with new High Efficiency Toilet(s) (HET toilets are those using 1.28 gallons per flush or less, including dual-flush toilets).

#### **Toilet Rebate Program Terms and Conditions**

- 1) Rebate program begins February 21, 2010. Purchases made prior to that date are not eligible for rebates.
- 2) Rebates are one time per property. The property receiving the rebate must be a water customer of the City of Paso Robles. A maximum of two toilets per property are eligible for a rebate.
- 3) Rebate funds are reserved for each customer at the time the completed application is submitted. The rebate amount will not exceed the total cost of the device and installation (if installation done by a licensed plumber), excluding tax.
- 4) Rebate checks will be issued for completed applications only.
- 5) Toilet installations are subject to on-site verification by City staff prior to rebates being issued.
- 6) Rebates will be paid as long as funds are available. The program may expire or change at any time.

#### **How Do I Apply?**

- 1) Complete an application form and submit with an invoice attached that indicates the toilet manufacturer and model number.
- 2) If your toilet qualifies, a rebate check will be mailed within 30 days of the post inspection.
