Needs: For the City Council to adopt the attached resolution awarding the low bid for Landscape Maintenance of Parkways & Medians to Tom Flynn & Sons Landscape, Inc. of Paso Robles, California.

Facts:

1. Three (3) bids were received on June 3, 1999, with the low bid submitted by Tom Flynn & Sons Landscape, Inc. Award will be in the amount of \$2,519.
2. Due to budget constraints and/or the low amount of maintenance required, some bid items have been deleted from the contract. These items are low maintenance items and will be maintained by City crews. Items are as follows:

3. Funding for this project is part of the maintenance and operations budget for the Public Works Department.

Analysis and Conclusion:

The bids received were reviewed by staff and it is recommended that the bid be awarded in the amount of \$2,519.00, for Bid Items 1, 4, 5, 6, 7, 8, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 22, 23, 24, 25, 26, & 27, only, for the Landscape Maintenance of Parkways & Medians to Tom Flynn & Sons Landscape, Inc. of Paso Robles, California.
