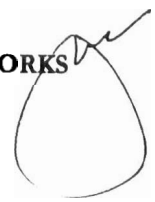

13TH/24TH STREET BRIDGES
DATE: JULY 20, 1999



Needs: For the City Council to consider awarding the contract to the low bidder to perform the seismic retrofitting of the 13th and 24th Street Bridges.

- Facts:**
1. Bids will be opened on July 15, 1999. Staff will make a verbal presentation at the meeting as to the low bidder.
 2. Funding for this project will be coming from Federal and State Grants.
 3. The City Council previously authorized staff to enter an Agreement with the State to administer the construction contract for this work.
 4. The work must be undertaken quickly to avoid the winter rains.

Analysis and

Conclusion: The State is paying for this seismic retrofit work to both bridges. The City will administer the contract. The California Department of Fish and Game only allows work within the Salinas River during the months of May through October. It is recommended that this construction work be awarded quickly to take advantage of the summer months.
