AIRPORT CRASH EQUIPMENT

Needs: For the City Council to adopt attached Resolution #04-xx authorizing the application for State funding to match the Federal Grant for Airport Crash Rescue Equipment.

Facts:

1. The City has received Federal grant funding from the FAA for the acquisition of replacement of Airport Crash Rescue equipment.
2. The State grant program, available through the State Department of Transportation (CALTRANS), Aeronautics Program, provides for additional funding to the City in the amount of 5% of the Federal grant.
3. The State grant application process requires the specific authorization by Resolution of the governing body to make the required application submittals.

**Analysis
and**

Conclusion: The City Council has approved the proposed equipment acquisition, authorized the Federal grant funding acceptance, and made the required budget appropriation by previous action. This request provides for additional funding to be used for the acquisition, in lieu of local money, for the City's grant match. The City qualifies under the provisions of the State funding program. The funding is available, pending the satisfactory completion of the application requirements.

Impact: The total cost of the equipment acquisition is \$ 62,600.00. The FAA share is 95%, or \$ 59,504.00. The State Aviation Program would fund up to 5% of the federal amount, or **approximately \$2,975.00** for this project. The remaining City share would be \$ 121.00.

- A. Adopt Resolution #04-xx, authorizing the application process for the State grant funding, as outlined, together with the execution of all pertinent documentation, as required.
- B. Amend, modify, or reject the above option.
