1. Earthquake 2003: Recovery – Red-tagged Building Access

Consider merchant's request for limited entry to buildings that have been red-tagged as extremely hazardous and unsafe for entry.

Mayor Mecham opened the public hearing. Councilmember Nemeth, seconded by Councilmember Picanco, moved to allow limited entry to red-tagged buildings upon completion of the following:

- Entry party's engineer prepares entry strategy;
- All parties (merchant, property owner, entry party(s) and entry design engineer) execute City liability waivers and indemnification agreements, as approved by the City Attorney;
- City Emergency Services personnel have reviewed the entry strategy (not for approval, but for rescue information);
- Entry strategy is executed by appropriately licensed private professionals;
- Qualified City Emergency Services equipment & personnel can be made available on scene during the entry.
- Structural engineer must remain on site during the entire entry operation.
