SUBJECT: Parking Restrictions at the Intersection of 10th and Pine Streets
DATE: February 17, 2004

NEEDS: For the City Council to consider a request for parking restrictions (red curb) on the northeast corner of the intersection of 10th and Pine Streets.

FACTS:

1. The City received a request from about sight line visibility at the intersection of 10th and Pine Streets. Only the northeast corner is without parking restrictions. Restrictions were requested at this location to improve sight line visibility and make the intersection safer.
2. The Streets and Utilities Committee voted 2-0 to recommend approval of the parking restrictions (red curb) to the City Council.

ANALYSIS &

CONCLUSION: The intersection of 10th Street at Pine has four corners with handicap ramp access to the street (which prohibits parking near the corner). In addition, three of the four corners have other features that inhibit parking (bulb out, fire hydrant red curb or no curb at all). Site line can be improved with the installation of red curbing on 10th Street, beginning at the northeast corner handicap ramp extending eastward 20 feet.

IMPACT:** Minimal (existing budget)

OPTIONS:

- a. Adopt Resolution No. 04-xx approving parking restrictions on 10th Street from the northeast corner handicap ramp extending eastward 20 feet.
- b. Amend, modify or reject the above option.

RESOLUTION NO. 04-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES
APPROVING PARKING RESTRICTIONS (RED CURB) ON THE NORTHEAST
CORNER OF THE INTERSECTION OF 10TH AND PINE STREETS

WHEREAS, the only corner of the intersection of 10th & Pine Streets without parking restrictions near the corner is the northeast corner; and

WHEREAS, site line can be improved with the installation of a red curb on 10th Street beginning at the northeast corner handicap ramp extending eastward 20 feet; and

WHEREAS, the Streets and Utilities Committee reviewed the request and voted 2-0 to recommend approval of the parking restrictions (red curb) to the City Council.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The City Council of the City of El Paso de Robles does hereby approve parking restrictions (red curb) on 10th Street from the northeast corner handicap ramp, extending eastward 20 feet.
