## **PRESENTATION**

**Welcome Remarks from Frank Mecham, Mayor** – The Mayor thanked the Advisory Committee members for their hard work, dedication and leadership. He provided an update of the Governor's action, this same day, to formally request the President declare a major disaster for the State of California and specifically San Luis Obispo County.

1. **EARTHQUAKE DAMAGE ASSISTANCE -**

Consider leading and conducting a letter writing campaign to elected officials to urge Presidential disaster decree. It is important that the community articulate with emphasis the financial burden of earthquake damage on our small community. As advocates for various represented groups, advisory body members are asked to consider writing letters both individually and on behalf of the named body to underscore the dire need to invoke a Presidential decree of disaster area in Paso Robles and SLO County.

Barbara Partridge, Director of Library and Recreation Services made a presentation of how the Advisory Committee members could assist in the letter writing campaign by encouraging their Congressional representatives and Senators to urge President Bush to approve the Governor's request for declaration of a disaster for San Luis Obispo County, or to write directly to the President.

Barbara Partridge responded to several questions that followed regarding who and how to contact these elected officials.

Councilman Gary Nemeth provided his comments and thanks to the Advisory Committee for their hard work for the community.

A motion was made by Chuck Miller (Citizen's Airport Advisory Committee) and seconded by Dr. B. R. Bryant (Pioneer Museum Board of Trustees) to accept the recommendation to lead a letter writing Campaign to elected officials to urge Presidential disaster decree which has been requested by the State/Governor.

The motion was passed by a consensus voice vote.

**ADJOURNMENT** – by general consensus of the members in attendance the respective Commissions/Advisory Bodies adjourned to their next regular meetings. The meeting adjourned by 4:30PM
