SUBJECT: **Barney Schwartz Park Concessions**
DATE: June 1, 2004

Needs: For the City Council to consider an ad hoc committee recommendation for Barney Schwartz Park concession operations.

Facts:

1. At their April 6, 2004 meeting, Council directed staff to solicit concession operation proposals for Barney Schwartz Park that would allow an option for alcohol sales.
2. The City received three proposals for concession operations: B&G Concessions (no alcohol sales), Hospitality Catering (alcohol sales) and Riggs & Sudik, Inc. (alcohol sales).
3. The ad hoc committee reviewed all proposals, and recommends to the full Council that they award concession operations to B&G Concessions.
4. The City may, at their discretion and under separate permit and conditions as listed in the concession contract, sell alcohol at adult events programmed at Barney Schwartz Park.
5. The ad hoc committee recommends that, unless permitted by the City, the no alcohol policy be enforced by a combination of Barney Schwartz Park staff and the Police Department. It further recommends that additional signage be placed at the beginning of all spokes leading to the softball complex that read "No Alcohol Beyond This Point."

Analysis & Conclusion: The City currently has an interim concessionaire at Barney Schwartz Park (Paso Robles Girl's Softball League). In order to secure a contracted concessionaire, proposals were accepted by the City, and reviewed by an appointed ad hoc committee. This committee recommends awarding the contract concession operations to B&G Concessions, which has opted not to sell alcohol, an option provided for within the contract. This will allow the City to provide alcohol sales at their discretion. It is further recommended by the ad hoc committee that, unless otherwise permitted, the no alcohol policy be enforced by a combination of Barney Schwartz Park staff and the Police Department.

Thank you for the opportunity to bid on the vendor spaces at Barney Schwartz Park.





PERSONNEL AND STAFFING

Staffing will be initially scheduled and managed by the owners and the Area Manager. With a source of 70 plus employees, opportunities are available for existing employees as well as new hires. We will hire, or promote from within our company a full time concession operations manager for Barney Schwartz Park. This will be done immediately on the award of the proposal to Riggs & Sudik, Inc. This person will report directly to the Owners of the company. We currently have several excellent candidates for the position.

The concession stand(s) will be staffed during all regular scheduled sporting events, including adult and youth league play, and all adult and youth organized tournaments sponsored or co-sponsored by the city. Concession operations will be opened by the first league/tournament game of any day and remain opened until the completion of the last league/tournament game of any day as described in the RFP. Staffing will be scheduled to ensure fast, efficient customer service.

Scheduling will be done in a concise organized manner using current methods within our company. This method includes tracking customer count, time required to serve each customer, time required for cleaning upon opening and closing the concession stands. Using these methods ensures that at no time the operations are understaffed. Also inventory is tracked and maintained at an efficient level using a computerized POS system, ensuring product is on hand.

- **Paso Robles Girls Softball League:** B & G concessions have been awarded the concession for Paso Robles Girls Softball League for the previous five seasons and again for the 2004 season. The season runs from March through June. The concessions are supplied for the 800 members of the league on Saturday's during the season. In June, the league holds an annual softball tournament and B & G Concessions has staffed up to three locations for approximately 2500 people in attendance. The clientele consists of parents, coaches, players and friends in the community. Foods at the concession stand include, specialty sandwiches, hamburgers, hot dogs, sodas, candy, chips, coffee and cocoa.
- **Annual Surf and Turf.** B & G Concessions caters an annual dinner party in November for Eagle Castle Winery, Jon and Jan Dallons are the owners. This event, B & G Concessions are responsible for the foodservice and helping with the set up and preparation of this private event. The annual event takes place at the Dallons home in Paso Robles.
- **SLO VETTES.** B & G Concessions have been awarded a couple of events for the SLO Vettes club. The most recent was a steak dinner in Paso Robles in December, 2003. B & G Concessions was responsible for all aspects of the foodservice for this event. SLO Vettes also used B & G Concessions for a breakfast barbeque a few years ago.
- **Native Sons Parlor 150.** The events B & G Concessions have catered for this group include, Memorial Day, Cruise night, Father's Day and district barbeques. The foodservice for these events consists of a barbeque fundraiser.
- **Barney Schwartz Park** As of March 21, 2004, B & G Concession (through Paso Robles Girls Softball League) is currently operating the concession stand at Barney Schwartz Park for the league. B & G Concession is staffing the concession stand Monday thru Friday at the park.

With over 10 years experience in catering, public works and foodservice, B & G Concession knows they can offer a stable, reliable business to the people and the community who frequent the Barney Schwartz Park. B & G Concessions have had a great acceptance at the park since March, 2004 and have already built quite a strong clientele. B & G Concessions will continue to improve the quality of the foodservice at Barney Schwartz Park through the relationships and suggestions they have already formed.

B & G Concession is open to any menu idea the park may have and can address most menu requests with proper notice. We are, however, choosing to opt out for any alcohol sales at this time.
