SUBJECT: Award a Construction Contract for Installation of Equipment to Control the Flow of a Sulfur Spring at City Hall Parking Lot
DATE: May 4, 2004

NEEDS: For the City Council to consider awarding a construction contract for the installation of equipment to control the flow of a sulfur spring at City Hall parking lot.

FACTS:

1. At the April 20 2004 City Council meeting the Council instructed staff to clarify the discrepancy of two bid items on the sulfur spring bid proposals. The two bid items were mobilization and casing installation costs.
2. Staff reviewed the bid items with Maggiora Bros. Drilling who explained that they included additional funds in the mobilization bid item to cover uncertain casing installation costs. Associated Pacific Constructors included the cost of a grade beam in the "valve and fittings" bid item rather than on the separate grade beam bid item, which accounted for the discrepancy in their materials cost.
3. The Council also instructed staff to call the low bidder's references. Staff called the references and all responses were favorable relating to work schedules, work quality and overall working relationship with the contractor's clients.

**ANALYSIS
AND**

CONCLUSION: Contractors were invited to submit their proposals by Friday, April 3, 2004.

The City received only two bids: one from Maggiora Bros. Drilling for \$180,500 and another at from Associated Pacific Constructors for \$70,953. Because of the uncertainty of the project, Maggiora included additional labor, equipment, and material costs in their mobilization bid item rather than on the per linear foot casing installation bid item.

Staff finds that the low bid received from Associated Pacific Constructors, Inc. in the amount of \$70,953 is a responsive bid. Associated Pacific's references were called and all respondents gave very favorable recommendations related to Associated Pacific's project time schedules, work quality, and overall working relationships.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES

WHEREAS, the December 22, 2003, earthquake ruptured a thermal sulfur spring underground that surfaced in the City Hall parking lot; and

WHEREAS, in accordance to the City's adopted Purchase Policy and Uniform Public Construction Cost Accounting Act (UPCCAA), bid documents for a construction contract for the installation of equipment to control the flow of sulphur spring at City Hall parking lot were prepared and put out to bid; and

WHEREAS, at the deadline to submit a proposal, one proposal was received in the amount of \$180,500 and another at \$70,953. City staff reviewed the two bids and determined that the bid received from Associated Pacific Contractors, Inc. in the amount of \$70,953 is a responsive bid.

WHEREAS, per City Council direction of April 20, 2004, staff reviewed both bids to clarify discrepancies in Maggiora Bros. materials costs and called the low bidders references, all with favorable results.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The City Council of the City of El Paso de Robles does hereby accept staff's recommendation to award the construction contract for the installation of equipment to control the flow of sulphur spring at City Hall parking lot.

SECTION 2. The City Council of the City of El Paso de Robles does hereby authorize the City Manager to enter a contract with Associated Pacific Contractors, Inc. in the amount of \$70,953 under Budget No. 100.820.5452.260.
