SUBJECT: Award Construction Contract for Repair of the Centennial Park Gymnasium from the San Simeon Earthquake
DATE: November 16, 2004

Needs: For the City Council to consider awarding a construction contract to repair earthquake damage to the Centennial Park Gymnasium.

Facts:

1. The San Simeon Earthquake that occurred on December 22, 2003, caused minor damage to the Centennial Park Gymnasium.
2. Repairs to the Centennial Park administration building were bid separately and are already under way, independent of the gymnasium repairs.
3. The City solicited bids for the gymnasium repairs under the adopted Purchasing and Payment procedures for projects under \$ 100,000.00.

Conclusion: At the Bid Opening on October 7, 2004 two bids were received:

Thiessen Construction	\$ 35,700.00
Newton Construction	\$ 49,895.92

Staff reviewed the bid submitted by Thiessen Construction and found it to be a responsive bid.
