SUBJECT: Rescue Equipment Purchase

DATE: March 21, 2006

NEEDS: For the City Council to authorize the Chief of Emergency Services to purchase Rescue Equipment.

FACTS:

1. A variety of specialized rescue equipment is utilized by firefighters operating at the scene of emergencies.
2. In the adopted budget, Council allocated Emergency Services \$92,200 to purchase heavy breaking/breaching equipment for rescue functions. This rescue equipment represents a significant portion of that equipment.
3. In accordance with Section 3.0 of the Purchasing and Payment Procedure Manual, Emergency Services solicited bids for rescue equipment.

ANALYSIS &

CONCLUSION: Vendors were invited to submit sealed bids for the items included in Attachment 1 by Friday, March 3, 2006. Emergency Services received two qualifying bids of \$20,110 and \$21,537.

Staff recommends acceptance of the low bid of \$20,110, submitted by All-Star Fire Equipment, and authorize the purchase of rescue equipment detailed in Attachment 1.

FISCAL

IMPACT: \$12,950 currently allocated in 100.220.5212.150 and \$7,160 currently allocated in 100.220.5454.150 and approved by Council Resolution 05-112.

- a. Adopt Resolution No. 06-XXX authorizing Emergency Services to purchase rescue equipment for \$20,110 from All Star Fire Equipment, or;
- b. Amend, modify or reject above option.

WHEREAS, competitive bids were obtained as required by City Purchasing Rules.

THEREFORE, BE IT HEREBY RESOLVED that the City Council of the City of El Paso de Robles authorizes the Chief of Emergency Services to purchase rescue equipment from All Star Fire Equipment, in the amount of \$20,110.
