- Annual Fishing Derby is coming up in two weeks along with softball tournaments at Barney Schwartz Park

### DIRECTOR'S REPORT

- Concerts in the Park are off the charts with attendance in the City Park.
- Fourth of July celebration at Barney Schwartz Park – most felt this was better than last year.
- Discussed the Library's annual fundraiser, Midsummer Magic, on Saturday, July 8, was very successful.

### CITY COUNCIL COMMUNICATION

- Councilman Strong discussed a letter sent to City Council from REC Foundation regarding a large donation. Their original donation was to help master plan city parks. But instead of waiting for that project, they want their donation to be used on city projects needed now. Ann

is recommending a new playground apparatus at Centennial Park. Lynda would like to see shade structures at the Senior Center, etc. Councilman Strong said the list of projects are numerous for all the parks and city facilities.

- The League of California Cities bond will be on the November ballot for affordable housing that is running way behind.
- It was discovered the old Alliance building is a historical site and therefore Smart and Final will not be able to build in that facility.
- After discussion, In God We Trust motto will hang in the City Council Chambers with the City seal. There still may be some problems from the Federal or State government.

### **UNSCHEDULED MATTERS**

- Member Gustin has applied to be a member of the Planning Commission and his term is up on the Senior Citizen Advisory Committee as of June 30, 2006.
- The Senior Endowment Fund balance as of 6/26/06 is \$305,156.66. Chairperson Dutra asked about the \$1571 credit that does not show on this report? Lynda will check with Finance about this credit.
- Sugar Me Bakery has offered the Senior Center daily treats and that is where the treat for today is from.
- July 20 is the Annual Senior Citizen Luau at a cost of \$5. You have to make your reservation and sign up for a pot luck dish. There will be also be a photographer taking pictures so be sure and dress up for the event. We always have the best egg rolls.
