Councilmember Nemeth, seconded by Councilmember Hamon, moved to direct staff to implement a Downtown Parking Action Plan including seeking proposals from individuals qualified in parking management.

Further, the Downtown Parking Action Plan shall contain the following principles:

<i>Within Six Months</i>	Increase parking turnover and manage parking availability in the downtown through time restricted parking;
<i>Within Six Months</i>	Maximize underutilized downtown parking spaces by expanding the acceptable walking distance to 3-4 blocks, or 2-1/2 minutes; and
<i>Within One Year</i>	Plan for acquisition, construction, and maintenance of future parking facilities through implementation of a variety of funding sources, including fines; and
<i>Within One Year</i>	Explore transit options
