**SUBJECT:** Urban Water Management Plan Update  
**DATE:** November 20, 2007

---

**NEEDS:** For the City Council to open the noticed public comment hearing on the Draft 2005 Urban Water Management Plan and then to continue this item.

**FACTS:**

1. The City is required by regulations to prepare an Urban Water Management Plan (UWMP) to document the City's sources of water supply and water demands, present a contingency plan for water shortages, and document the City's demand management measures (water conservation efforts).
2. The City contracted with Todd Engineers to complete the 2005 UWMP update, and provided public notification of the availability of this draft document for review and comment. A public comment hearing was scheduled for the November 20, 2007 City Council meeting.
3. Since the draft was released, City staff has reviewed it and provided comments to Todd Engineers. The City staff's comments are significant and will require substantial revision to the draft. Given the significant scope of the City's comments, the public hearing will need to be re-noticed upon revision of this current draft.

**ANALYSIS &  
CONCLUSIONS:**

Accurately estimating water demand and supply is an important component in development planning. The UWMP evaluates population growth (i.e., development) per the City's General Plan and the corresponding water demand. Additionally, the UWMP evaluates the City's ability to meet water demands in normal conditions, as well as in single and multiple drought years. As currently written, the Draft 2005 UWMP projects adequate supplies until 2025 based on several key assumptions.

Revising these assumptions will change the conclusions and recommendations of the UWMP. Staff recommends accepting public comment at this time, and Todd Engineers will then incorporate staff and public comments into a new draft. Since revisions to the draft are likely to be significant, staff will provide a subsequent public review prior to final consideration of the UWMP.

**FISCAL  
IMPACT:**

City staff is reviewing the contract with Todd Engineers to determine if any contract amendments will be required to address this subsequent revision.

**OPTIONS:**

After consideration of all public comment, the City Council should consider the following options:

- a) Continue this item; or
- b) Amend, modify, or reject this option.
