Needs: That the City Council consider steps toward finalizing development plans for a residential development and subdivision.

Facts: 1. Applicant William Stoll has requested that Parcel Map PR 06-0012 be accepted by the City for recordation. Parcel Map PR 06-0012 is located at 1810 Park Street.

Conclusion: Parcel Map PR 06-0012 was tentatively approved by the Planning Commission on June 13, 2006. All conditions imposed by the Planning Commission have been satisfied. No annexation to the Community Facilities District will be required since the residential units on the property were permitted prior to Planning Commission approval of the subdivision.

Impact: Residential units on the property were permitted prior to Planning Commission approval of the subdivision, therefore no annexation to the Community Facilities District for public services is required.

- a. Adopt Resolution No. 08-xx accepting the recordation of Parcel Map PR 06-0012, a two-lot residential subdivision located at 1810 Park Street.

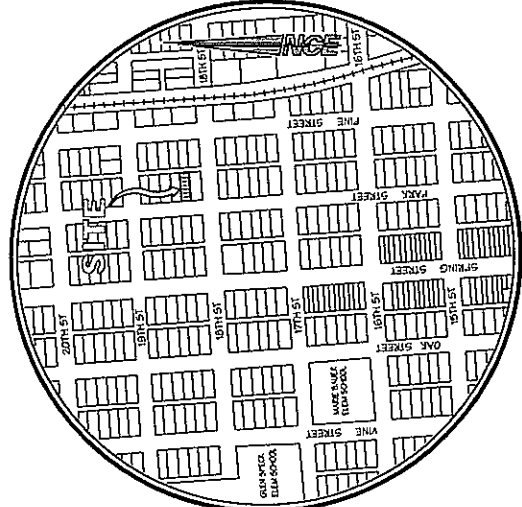

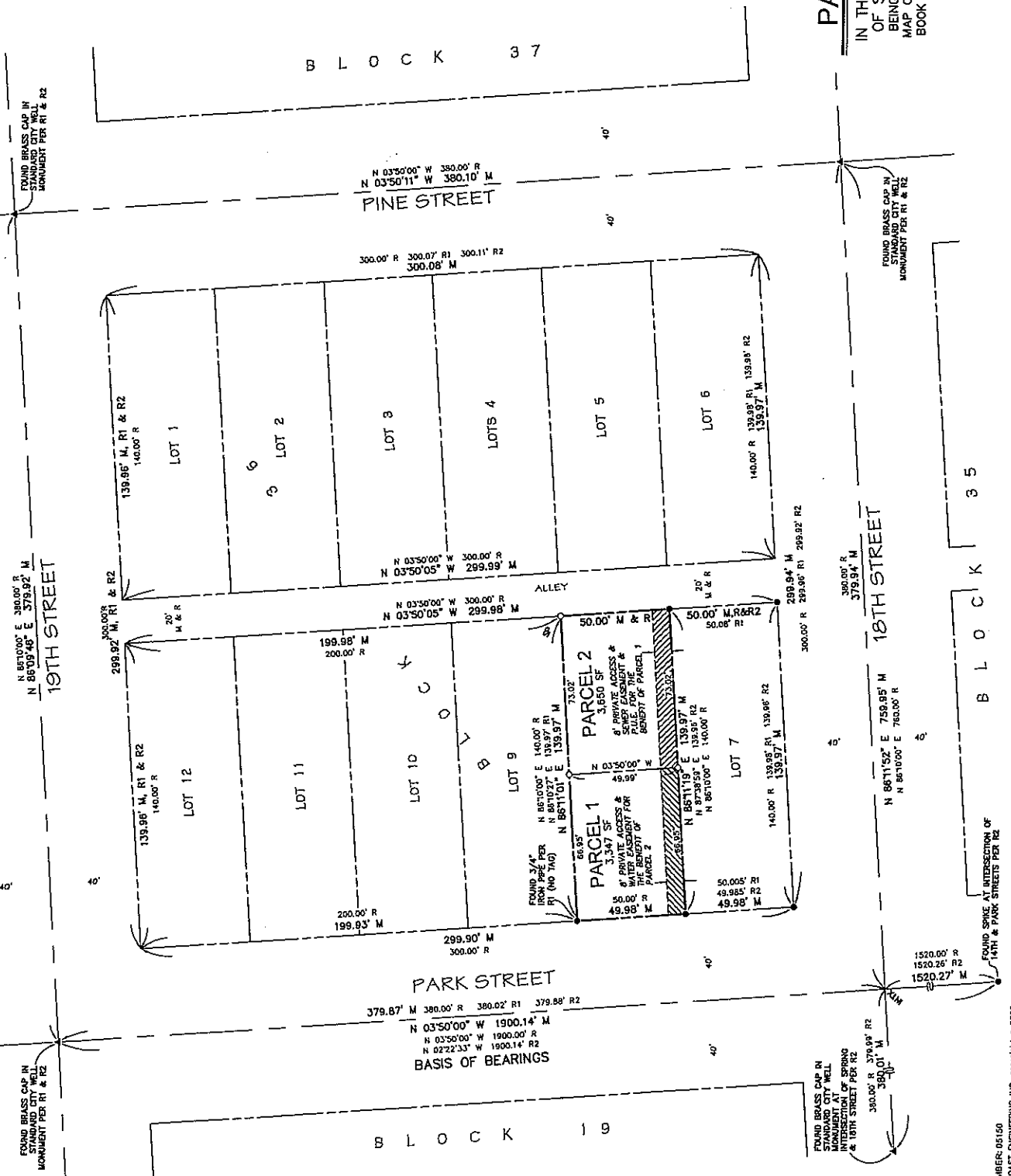
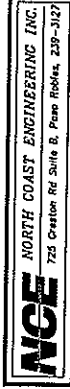
BASIS OF BEARINGS
