

**NOTICE OF INTENT TO CONSIDER  
A CODE AMENDMENT (08-001)**

**NOTICE IS HEREBY GIVEN** that the City of El Paso de Robles will hold two Public Hearings to consider a Code Amendment.

The Planning Commission will consider this item at a Public Hearing on Tuesday, June 24, 2008, and the City Council will consider this item and Introduce the Zoning Amendment at a Public Hearing on July 1, 2008. Both meetings will be held at 7:30 p.m. at the City of El Paso de Robles, 1000 Spring Street, Paso Robles, California, in the City Council Chambers.

The two hearings will consider the following project:

Code Amendment 08-001: A City-initiated Code Amendment to comply with a letter sent from the Federal Emergency Management Agency (FEMA) advising that the City's floodplain ordinance needs to be updated to conform to the most recent regulations included in the National Flood Insurance Program. The proposed amendments to the Floodplain Management Ordinance are mandated by FEMA as conditions for participation in the National Flood Insurance Program.

The proposed Code Amendment to be considered is a "ministerial" project, which is statutorily exempt from the California Environmental Quality Act per Public Resources Code Section 21080 for the reason that the City has no discretion over the changes.

Written comments on the proposed Code Amendment may be mailed to the Community Development Department, 1000 Spring Street, Paso Robles, CA 93446, provided that the comments are received prior to the time of the public hearing. Oral comments may be made at the hearing. Should you have any questions regarding this application, please call Ed Gallagher at (805) 237-3970.

If you challenge the Code Amendment application in court, you may be limited to raising only those issues you or someone else raised at the public hearings described in this notice, or in written correspondence delivered to the Planning Commission or City Council at or prior to the public hearing.
