PURCHASING AND PAYMENT PROCEDURES MANUAL, p.3-4, 8.02.05

Section 2.0 PURCHASES GREATER THAN \$2,500 BUT LESS THAN \$5,000

Given that there are adequate budget appropriations available and that no administrative restrictions have been imposed by the City's purchasing authority, an executive manager may purchase supplies and services over \$2,500 subject to purchase order approval from the City's purchasing authority. *The purchase order must be prepared and approved prior to the purchase commitment. The executive manager must endeavor to solicit three quotations, preferably written. Quotations should be attached or noted on the face of the purchase order.*

Preference to local vendors shall be encouraged given that quality, service and price are similar.

Section 3.0 PURCHASES GREATER THAN \$5,000

Given that there are adequate budget appropriations available and that no administrative restrictions have been imposed by the City's purchasing authority, an executive manager may purchase supplies and services over \$5,000 subject to purchase order approval from the City's purchasing authority. *The purchase order must be prepared and approved prior to the purchase commitment. The executive manager must solicit competitive bids prior to the preparation and issuance of a purchase order. Bid results should be attached or noted on the face of the purchase order.*

Preference to local vendors shall be encouraged given that quality, service and price are similar.

The water rate structure proposed at the last July 1 City Council meeting, if adopted, is to take effect on January 1, 2009. With no pending emergency evident and the decision on capacity charges delayed till August, I am wanting to know from Mr. Monn if either of the above City purchasing codes, Sec. 2 and 3, were followed in the hiring of a vendor or vendors to print and mail out the City's July 2008 "Water Rate Notice?" If you know the purchasing code was followed in the hiring of the vendor or vendors, who where the 3 vendors first contacted for either price quotations or competitive bids? Are quotations or competitive bids as attached to the purchase order now available through a public information request? Finally, if you believe the purchasing code was not followed, why not?

Mr. Monn, I would appreciate a verbal response to my questions tonight as well as a written response. Thank you.
