The City of Paso Robles, as a step towards barrier free access to City Facilities and Programs engaged National Access Consultants, LLC to perform a Site Evaluation Survey and Transition Plan. The Draft Transition Plan has been available since February 5, 2008 for public review and comment.

The survey identified each facility and program, noting barriers, actions to correct, priority, and target dates for action. The actions noted are designed to bring the barriers in conformance with the current Americans with Disabilities Act Accessibility Guidelines.

Tony Goldsmith and J. Winkler, of National Access Consultants, will present an overview of ADA Title II and the results of the site survey. This workshop is another opportunity to provide comment on the Draft Transition Plan.
