The Housing Authority of the City of Paso Robles operates Oak Park Public Housing, a 148 unit apartment complex. The City Council will interview and make appointments to fill two vacancies on the Housing Authority. One vacancy is "at-large" and may be filled

by any resident of the City of Paso Robles. One vacancy is for a “tenant commissioner” and must be filled by a resident of Oak Park.

The Project Area Committee (PAC) is an advisory body to the Paso Robles Redevelopment Agency, City Council and, depending upon the specific topic, project or program, the City’s Planning Commission. The PAC’s mission is to formulate recommendations from property owners, business owners, and other persons with interests in the approximate 1150-acre Paso Robles Redevelopment Project Area.
