Council determined that a sales tax oversight committee should be formed to meet twice annually to review use of the supplemental tax. The committee will be comprised of seven (7) members serving overlapping three (3) year terms, with a committee termination date twelve (12) years after implementation of the tax. The committee appointments would be open to city residents and non-city residents alike, with three (3) members to be selected via City Council majority vote and four (4) members (one each) to be recommended from community organizations. 14 candidates were interviewed on Thursday, February 21, 2013. THE COUNCIL THEN SHOULD MAKE A MOTION ON THE CHOICES TO FILL THE THREE VACANT COMMISSION SEATS. (THE MAYOR MAY, AT HIS DISCRETION, ASK FOR A WRITTEN BALLOT FROM EACH COUNCILMEMBER AND THE VOTES TALLIED AND REPORTED.)
