VOTING PROCEDURE

After interviews have been conducted, each member of the council will write down name of the applicant of his choice to fill a vacancy. The chairman of the meeting will then collect all councilmembers' ballots and read them aloud, indicating each councilmember's vote. (the chairman may, at his discretion, call for a voice vote on each applicant rather than a written ballot.)

A tally will be kept of all votes cast for each applicant, and the results of the tally shall be read aloud by the chair.
