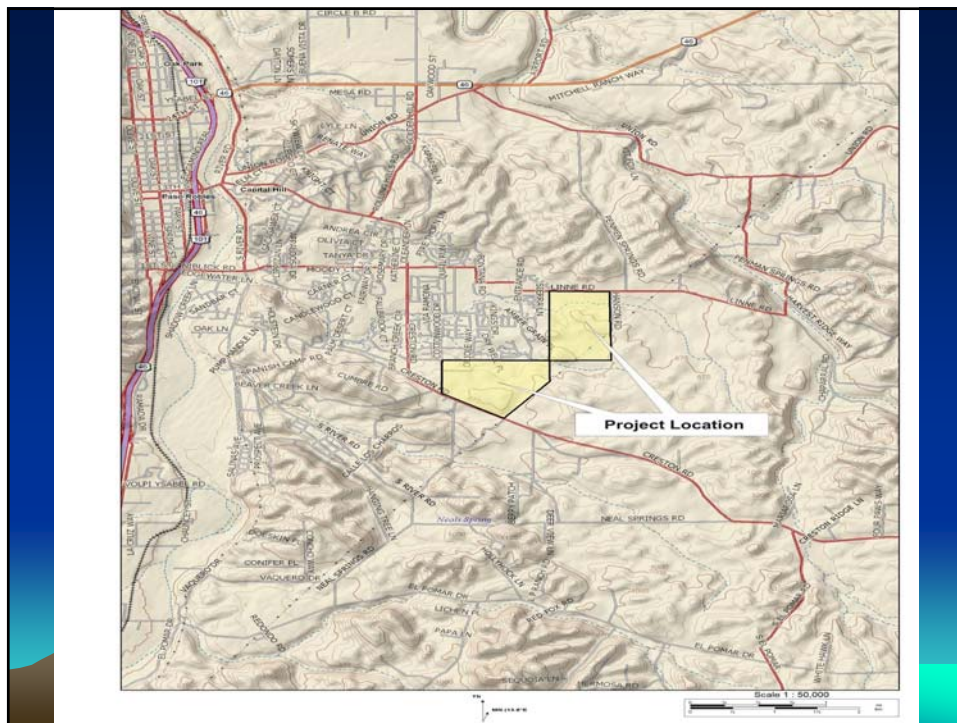

The Specific Plan Project

- Adoption and implementation of the proposed Specific Plan – provides a vision for the development of the Olsen Ranch and Beechwood properties based on the principles of traditional neighborhood design

Specific Plan

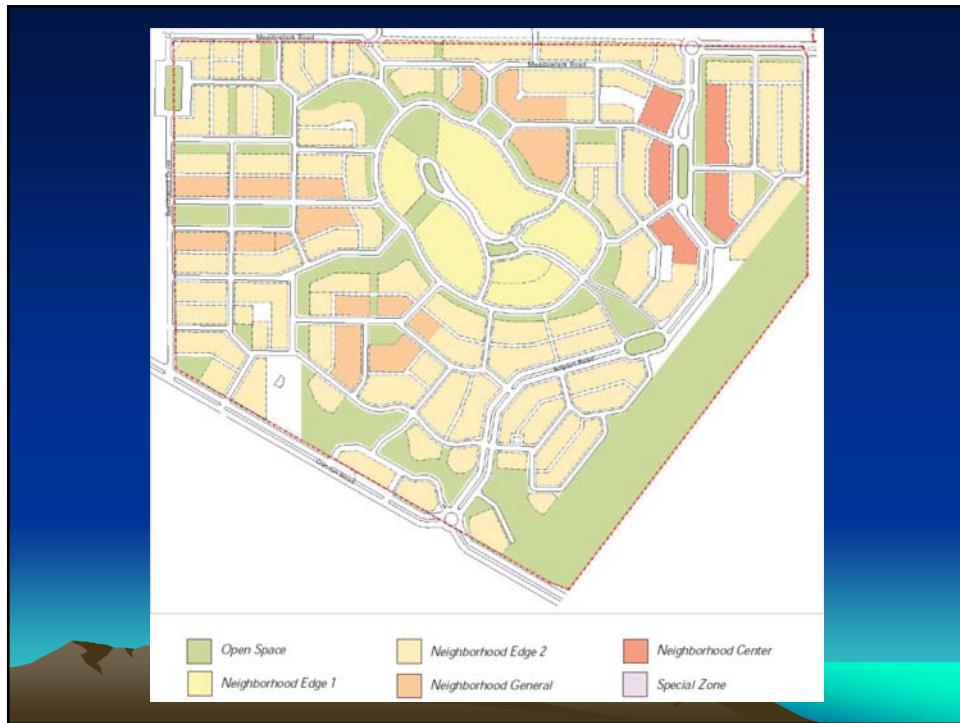
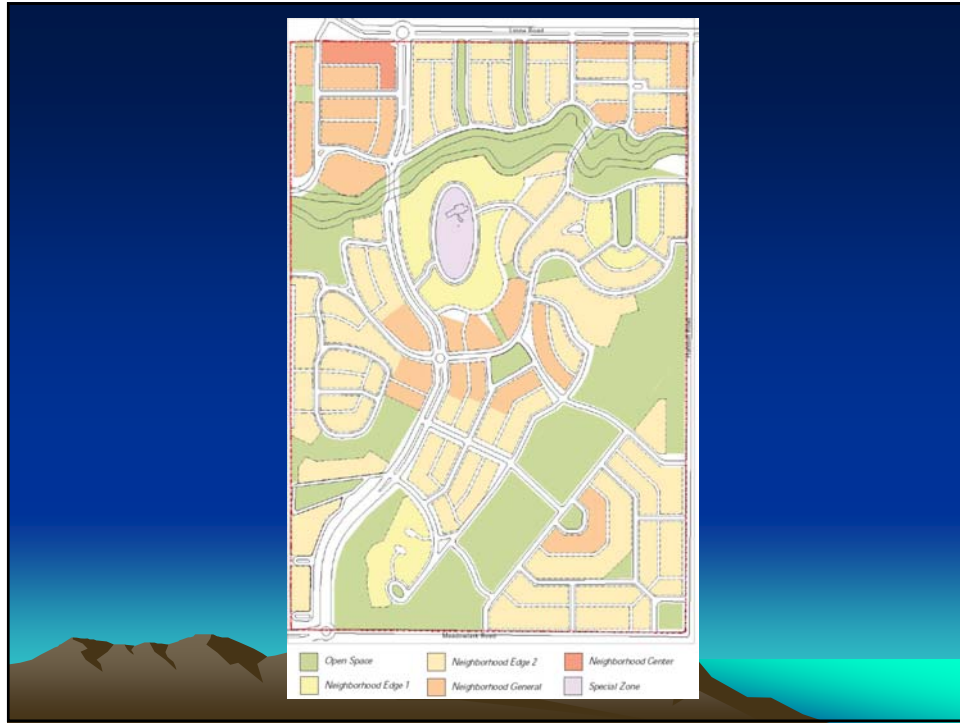
- Includes:
 - Strategies (policies and programs)
 - Physical actions (buildings)
- EIR will consider implications of both

Specific Plan Principles

- *An interconnected network of multi-modal thoroughfares is provided*
- *Parking is at the rear of buildings.*
- *Five-minute walk from center to edge.*
- *Neighborhoods with a clear center.*
- *Housing types for a variety of incomes and ages.*
- *Neighborhood centers catering to a mix of residential, retail and office uses.*
- *Carriage houses are encouraged.*
- *Schools are located within walking distance.*
- *A variety of open spaces are provided.*
- *Streets are suitable for pedestrians.*
- *Landscape is suitable for the setting and climate.*
- *Civic buildings are located in prominent sites.*

Specific Plan Proposals

- The EIR will evaluate two scenarios:
 - Proposed Specific Plan
 - 1,347 residences
 - 3,637 new residents
 - 53,000 sf non-residential
 - Higher-Density Option
 - 1,751 residences
 - 4,728 new residents
 - 69,000 sf non-residential
 - The higher-density option would require a General Plan Amendment, the proposed SP would not



CEQA

CEQA in Brief

- A decision-making tool which is intended to inform the public, decision-makers, and other interested parties of the potential adverse environmental consequences of these actions;
- Recommends mitigation measures to reduce the impacts as much as feasible;
- City is the Lead Agency; various responsible agencies;
- Specific Plan EIRs may exempt future residential development from further review if project conforms
