A RESOLUTION OF THE EL PASO DE ROBLES REDEVELOPMENT AGENCY
ADOPTING AND CERTIFYING THE ENVIRONMENTAL IMPACT REPORT
FOR THE PASO ROBLES REDEVELOPMENT PROJECT AREA

WHEREAS, the City of El Paso de Robles Redevelopment Agency, as the lead Agency, has prepared an Environmental Impact Report ("EIR"); for the Paso Robles Redevelopment Project Area; and

WHEREAS, on February 11, 1987, the Agency prepared and distributed a Notice of Preparation of the Draft EIR to responsible agencies pursuant to Title 14 California Administrative Code Section 15805(a); and

WHEREAS, the Agency (through its consultant, Community Systems Associates, Inc.) prepared and, on April 28, 1987, the Agency authorized the circulation of the Draft Environmental Impact Report, and filed a Notice of Completion of the Draft EIR with the State Office of Planning and Research, pursuant to Title 14 California Administrative Code Section 15085(a); and

WHEREAS, the Agency received comments on the Draft EIR from responsible agencies and from other interested persons and agencies and thereafter revised and supplemented to adopt changes suggested, to incorporate comments received and the Agency's responses to said comments, and as so revised and supplemented, a Final EIR was prepared and submitted to the Redevelopment Agency of the City of El Paso de Robles; and

WHEREAS, on October 15, 1987, the Redevelopment Agency held a duly noticed public hearing on the Final EIR at which hearing the opportunity was given for all interested persons expressing a desire to comment thereon or object thereto having been heard, and said Final EIR and all comments and responses thereto having been considered; and

WHEREAS, the Final EIR consists of the Draft EIR, as revised and supplemented incorporating comments received and the response of the Agency as of the date hereof.

NOW, THEREFORE, BE IT RESOLVED by the El Paso de Robles Redevelopment Agency that the Final Environmental Impact Report has been prepared and completed in compliance with the California Environmental Quality Act ("CEQA"), and State and local regulations and guidelines adopted pursuant thereto.

FURTHER RESOLVED that the Agency hereby finds that the information contained in the Final Environmental Impact Report has been reviewed and considered by the members of the El Paso de Robles Redevelopment Agency.

FURTHER RESOLVED that the Agency hereby finds and determines as follows with respect to the adverse environmental impacts detailed in the Final Environmental Impact Report:

a) That the environmental impacts set forth in the EIR including those raised in comments to the Draft EIR have been considered and recognized by the El Paso de Robles Redevelopment Agency.

b) That none of said impacts after mitigation will have a significant effect or result in a substantial, or potentially substantial, adverse change in the environment.


c) That the Environmental Impact Report does adequately consider the environmental impact.
