RESOLUTION NO. RA 87-05

A RESOLUTION OF THE EL PASO DE ROBLES REDEVELOPMENT AGENCY APPROVING AND ADOPTING RULES GOVERNING PARTICIPATION AND PREFERENCES BY OWNERS, OPERATORS OF BUSINESSES, AND BUSINESS TENANTS IN THE PASO ROBLES REDEVELOPMENT PROJECT AREA PURSUANT TO SECTION 33345 OF THE CALIFORNIA HEALTH AND SAFETY CODE

WHEREAS, the El Paso de Robles Redevelopment Agency is in the process of formulating a Redevelopment Plan for the Paso Robles Redevelopment Project Area pursuant to the California Community Redevelopment Law, Section 33000 et. seq. of the California Health and Safety Code; and

WHEREAS, Section 33345 of the California Health and Safety Code states that with respect to each redevelopment project the Redevelopment Agency shall, within a reasonable time before its approval of the Redevelopment Plan, adopt and make available for public inspection, rules to implement the operation of owner participation in connection with the plan; and

WHEREAS, Section 600.42 of the draft Paso Robles Redevelopment Plan provides for Owner Participation Rules in accordance with the implementation of the Redevelopment Plan; and

WHEREAS, said rules have been prepared and have been considered by the Redevelopment Agency at a public hearing after having been duly noticed, and having been available for public inspection in the office of the City Clerk of the City of El Paso de Robles for a period of ten (10) days.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED BY THE EL PASO DE ROBLES REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1. The Rules Governing Participation and Preference of Owners, Operators of Businesses, and Business Tenants in the Paso Robles Redevelopment Project Area, attached hereto and incorporated herein by reference, is hereby approved and adopted.

Section 2. The Executive Director of the El Paso de Robles Redevelopment Agency is hereby directed to make said rules available in the office of the City Clerk of the City of El Paso de Robles for public inspection and is directed to incorporate said rules as an appendix to the final Paso Robles Redevelopment Plan.
