RESOLUTION NO. RA 88-02

A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF EL PASO DE ROBLES MAKING FINDINGS AND DETERMINATIONS WITH RESPECT TO THE CONSTRUCTION OF CERTAIN PUBLIC IMPROVEMENTS OF BENEFIT TO THE PASO ROBLES REDEVELOPMENT PROJECT AND APPROVING AND AUTHORIZING EXECUTION OF THE AGREEMENT BETWEEN THE REDEVELOPMENT AGENCY AND SCHOOL DISTRICTS

WHEREAS, the City Council of the City of El Paso de Robles has heretofore adopted a Redevelopment Plan for the Paso Robles Redevelopment Project Area (the Project); and

WHEREAS, the Redevelopment Agency of the City of El Paso de Robles (the Agency), and the Paso Robles Elementary (Union) School District and the Paso Robles Joint Union High School District, collectively referred to as "School Districts" entered into a Memorandum of Understanding dated August 24, 1987 in connection with the adoption of the Redevelopment Plan for the Project and a proposed Agreement has been prepared between the Agency and School Districts which implements that Memorandum; and

WHEREAS, the Agreement is the subject of a public hearing by the City Council, notice of which has been published as required by law; and

WHEREAS, the Agency has prepared and submitted a report describing the proposed Agreement and the benefit of the public facilities described therein to the Project; and

WHEREAS, the terms and conditions of said Agreement have been approved by the City;

NOW, THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED BY THE REDEVELOPMENT AGENCY OF THE CITY OF EL PASO DE ROBLES AS FOLLOWS:

1. The Agency hereby finds and determines that the improvements as described in the proposed Agreement are of benefit to the Project and the immediate neighborhood in which the Project is located.

2. The Agency hereby finds and determines that no other reasonable means of financing the public improvements as described in the proposed Agreement are reasonably available to the School Districts.

3. The Agreement is hereby approved and the Agency Chairman is authorized to execute the Agreement on behalf of the Agency.
