RESOLUTION DECLARING THE WEEDS ON CERTAIN
STREETS AND SIDEWALKS TO BE NUISANCES.

Be it, and it is hereby resolved, that pursuant to an Act of the Legislature of the State of California entitled: "An Act Authorizing Municipalities to declare noxious or dangerous Weeds growing upon the Streets or Sidewalks, or upon Private Property, within municipalities, to be a public nuisance, creating a Lien upon the Property fronting upon such streets or sidewalks, or upon which such nuisance exists, for the Cost of Abating the same", approved May 26th, 1915:

It is hereby declared that the weeds now growing upon the streets and sidewalks of this City hereinafter specified, attain such a large growth as to become a fire menace when dry, and produce seeds of a noxious character, and the same are hereby declared to be a nuisance, and the Superintendent of Streets shall, after the passage of this resolution, post notices as under section three of said Act provided.

That said streets and sidewalks and the property in front of which nuisances exist are described as follows: the lot and block numbers of said property as well as the names of the streets, given herein according to the official map of said city, to wit:

TENTH STREET

Tenth Street on both sides from Spring Street to Vine Street, including the sidewalks.

The property on said Tenth Street in front of which said nuisance exists is described as follows: Blocks numbered 129, 130 and the "Hotel Grounds."

TWELFTH STREET

Twelfth Street on both sides from Hotel Grounds to Chestnut Street including the sidewalks.

The property on said Twelfth Street in front of which said nuisance exists is described as follows:

Lots seven and eight of Block 150; lots 1 and 22 of block 149; lots 7,8,9,10,11 and 12 of block 194; lots 1 and A, B and C of block 195.

THIRTEENTH STREET.

Thirteenth Street on both sides from the Railroad right of way to Chestnut Street, including sidewalks.

PARK STREET.

OAK STREET

Oak Street on both sides from the Hotel Grounds to Eighteenth Street, including the sidewalks.
