

RESOLUTION #229

Resolution Declaring Certain Weeds to Be Nuisances.

Be it and it is hereby Resolved: That pursuant to an Act of Legislature of the State of California, entitled: "An Act Authorizing Municipalities to Declare Noxious or Dangerous Weeds Growing Upon the Streets or Sidewalks, or upon Private Property, within Municipalities, to be a Public Nuisance, Creating a Lien Upon the Property fronting upon such Streets or Sidewalks, or upon which such Nuisance Exists, for the Cost of Abating the same," approved May 26th, 1915:

It is hereby declared that the weeds now growing upon the streets and sidewalks of this City hereinafter specified, attain such a large growth as to become a fire menace when dry, and produce seeds of a noxious character, and the same are hereby declared to be a nuisance, and the Superintendent of Streets shall, after the passage of this resolution, post notices as under section 3 of said act provided.

That said streets and sidewalks and the property upon and in front of which such nuisances exist, are described as follows, the lot and block numbers of said property, as well as the names of the streets and other designations, being given herein according to the official map of said City, to wit:

NINTH STREET.

Ninth Street on the North side thereof from Spring Street to Pine Street.

The property on said ninth Street in front of which said nuisance exists is described as follows:

Block 112, Lots 12 and 13 in Block 110 (Hotel and Cottages)
Block 130, Block 129, xxx "Springs and Bath House", Lots 7 and 8 of Block 28, Lots 1 and 18 of Block 116.

TENTH STREET

Tenth Street on both sides from Pine Street to Vine Street, including the sidewalks:

The property on said Tenth Street in front of which said nuisance exists is described as follows: Blocks 129, 130; Lots 1 and 12 of Block 147; Lots 6 and 7 of Block 146 and "Hotel and Cottages."

TWELFTH STREET

Twelfth Street on both sides from Spring Street to Chestnut Street including the sidewalks.

The property on said Twelfth Street in front of which said nuisance exists is described as follows:

OAK STREET

Oak Street on both sides from the Hotel Grounds to Twentieth Street, including the sidewalks.

VINE STREET

Vine Street on both sides from Tenth Street to Eighteenth Street, sidewalks included.

OLIVE STREET

Olive Street on both sides from Twelfth to Seventeenth Street, including sidewalks.

The property on said Olive Street in front of which said nuisance exists is described as follows:

Lots 1 and 12 of Block 194; lots 1 and 12 of block 193; lots 7, 8, 9, 10, 11 and 12 of block 150 and lots 7, 8, 9, 10, 11 and 12 of block 151; lots 7, 8, 9, 10, 11 and 12 of block 152; lots 7, 8, 9, 10, 11 and 12 of block 153; lots 7, 8, 9, 10, 11 and 12 of block 154; lots 1 and 12 of block 192; lots 1 and 12 of block 191 and lots 1 and 12 of block 186.
