

RESOLUTION NO. 411
 OF THE CITY COUNCIL OF THE CITY
 OF EL PASO DE ROBLES

WHEREAS, the City of El Paso de Robles did by a deed dated June 17, 1940 and recorded June 19, 1940, in Volume 279 at Page 66 of Official Records of the County of San Luis Obispo, acquire the property hereinafter described as Parcel One from THOMAS A. OSBORNE and OLIVE E. OSBORNE and,

WHEREAS said property was acquired after the lien date of the San Luis Obispo county taxes and,

WHEREAS, the City of El Paso de Robles did by a deed dated July 21, 1941 and recorded July 30, 1941, in Volume 300 at Page 271 of Official Records of the County of San Luis Obispo, acquire the property hereinafter described as Parcel Two from HANS N. AAROE and ANNA B. AAROE and,

WHEREAS said property was acquired after the lien date of the San Luis Obispo county taxes and,

WHEREAS said property is described as follows to-wit:

PARCEL ONE -- Lots 47, 48, 49 and the Northerly ~~40.10~~ acres of Lot 50 of Rancho Santa Ysabel.

PARCEL TWO -- That part of Lots 52 and 53 Rancho Santa Ysabel, beginning at a point which is the South-west corner of Lot 52; then Easterly along South line of said Lots 52 and 53 a distance of 1724.4 feet more or less to a point marked by an iron axle; then Northerly along a line parallel to West line of said Lot 52 a distance of 500 feet, etc. to point of beginning.

and,

WHEREAS said property was acquired by the City of El Paso de Robles and because of this public ownership it is not subject to sale for delinquent taxes,

NOW THEREFORE, be it and the same is hereby resolved by the City Council of the City of El Paso de

Robles in a regular meeting held this 15th day of December 1941, that the City Clerk of the City of El Paso de Robles be and he hereby is instructed to request the Board of Supervisors of the County of San Luis Obispo, California to order the auditor of the County of San Luis Obispo, with a written consent of the District Attorney, to cancel all uncollected taxes, penalties, or costs heretofore levied on the above described property.

BE IT FURTHER RESOLVED that the City Clerk of the City of El Paso de Robles be and he hereby is instructed to send a certified copy of this resolution to the Board of Supervisors and to furnish them with any satisfactory proof that they may request for the cancellation of said taxes.
