

RESOLUTION NO. 562

RESOLUTION CONCERNING THE USE OF SPACE IN THE POLICE DEPARTMENT TO THE ARMY SERVICE FORCES OF THE UNITED STATES.

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES RESOLVE AS FOLLOWS:

That the office space on the ground floor in the rear of police headquarters, 711-13th Street, El Paso de Robles, California, containing approximately Eighty square feet, be reserved of the use of the Army Service Forces, South Pacific Division, for Two days a week for a period to extend for the duration of the Army Recruiting Program, said use to be solely for the purposes of recruiting for the Army of the United States.

BE IT FURTHER RESOLVED that L. D. Hirschler, the Mayor of this City, be authorized to execute a Use Permit on behalf of this City and in accordance with the provisions of Section 850 of Act 5233, of the General Laws of the State of California.

BE IT FURTHER RESOLVED that said Use Permit is attached hereto, together with its terms and conditions and consideration of ONE DOLLAR (\$1.00) and made a part hereof.

USE PERMIT

STATE OF CALIFORNIA

COUNTY OF SAN LUIS OBISPO

IN CONSIDERATION of the sum of one dollar (\$1.00) and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned, hereinafter called the "Permitter," grants to the United States of America, hereinafter called the "Government," a permit upon the following terms and conditions:

1. The Permitter hereby grants to the Government a right to enter and use the premises hereinafter described for a period to extend for the duration of the Army Recruiting Program to be used for a Recruiting Station for the United States Army.

2. All equipment, tools, improvements and other properties placed upon the premises by the Government shall remain the property of the Government and may be removed by the Government at any time within a reasonable period after the expiration of this permit.

3. The Permitter hereby waives and releases any and all claims for damages arising from the activity of the Government, its officers, agents, employees, representatives or assigns on said property in the reasonable exercise of this permit.

4. It is understood and agreed that the area herein described is to be used two days of each week and that the employees of the permitter may have the joint use of the premises.

5. The property effected by this permit is located in the City of Paso Robles, County of San Luis Obispo, State of California, and is described as follows:

Approximately eighty (80) square feet of office space on the ground floor in the room located immediately in the rear of the police headquarters, 711 13th Street, Paso Robles, Calif.
