

RESOLUTION NO. 1114A RESOLUTION CANVASSING RETURNS AND DECLARING
RESULT OF BOND ELECTION HELD MAY 26, 1959

RESOLVED, by the City Council of the City of El Paso de Robles, San Luis Obispo County, California, that

WHEREAS, said Council by Ordinance No. 222 adopted on the 6th day of April, 1959, duly called and ordered held in the said City a special municipal bond election on the 26th day of May, 1959, for the purpose of submitting to the qualified electors thereof the propositions therein set forth;

WHEREAS, said special municipal bond election was held and conducted on said day, as required by law and said Ordinance;

WHEREAS, it appears that notice of said election was duly and legally given, that voting precincts were properly established therefor, that polling place cards and sample ballots were mailed to all registered voters in the City, election officers were appointed and election supplies furnished; and that in all respects said election was held and conducted and the votes cast thereat received and canvassed, and the returns thereof made, determined and declared in the time, form and manner as required by the laws providing for and regulating municipal bond elections in said City;

WHEREAS, the Council of said City met at the Council Chambers thereof on Monday, June 1, 1959, to canvass the returns of said election and declare the result thereof;

WHEREAS, said canvass was duly completed and the results thereof are as hereinafter set forth;

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED and RESOLVED, as follows:

1. That said special municipal bond election was held and conducted in the City of El Paso de Robles, County of San Luis Obispo, State of California, on Tuesday, May 26, 1959, in the time, form and manner required by law.

2. That there were two (2) voting precincts established in said City for the purpose of holding said election, which consisted of consolidations of El Paso de Robles County Election Precincts as last established by the Board of Supervisors of the County of San Luis Obispo for the conduct of State and County elections and which were designated Consolidated Election Precincts No. "A" and "B".

3. That a canvass of the votes cast in said City upon the measures thereat submitted was duly held in accordance with the order of the Council and in accordance with law.

4. That the whole number of votes cast at the said precincts in said City of El Paso de Robles at said special municipal bond election was 450.

5. That the proposition voted upon in said special municipal bond election, the number of votes received for and against said proposition in the precincts established therefor are as follows:

PROPOSITION NO. 1: Shall the City of El Paso de Robles incur a bonded indebtedness in the principal amount of \$200,000 for the acquisition, construction and completion of a sanitary sewage pump station and trunk sewer mains and the acquisition of easements necessary therefor?

6. That no duly registered voters, who expected to be absent from their respective election precincts on the day of the election secured ballots from the City Clerk.

7. That the City Clerk has certified to this Council that none of said absentee ballots issued or mailed by him have been returned within the time required by law.

8. That the City Council canvassed said absentee ballots and counted the same personally, whereupon it was found that the result of the ballots cast by said absentee voters, without regard

to the precincts within which the voters are registered, were no votes for and no votes against said proposition.

9. That the total number of votes cast in said City for and against the proposition is as follows:

10. That more than two-thirds of all the votes cast for and against said proposition at the special municipal bond election were in favor of the proposition and authorized the incurring of the bonded debt for the purpose set forth in the proposition and the proposition carried.

11. That the City Clerk be, and he is hereby, instructed to enter this resolution, in full, on the minutes of this Council as a statement of the result of said special municipal bond election.


