

RESOLUTION NO. 1138

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES TO OPEN 24TH STREET FROM PARK STREET TO CALIFORNIA HIGHWAY 41 AT YSABEL AVENUE IN THIS CITY

WHEREAS, due to the relocation of the United States Highway 101 in the City of El Paso De Robles, a new by-pass has been constructed for said highway between Riverside Avenue and the Salinas River in this city; and

WHEREAS, resulting from such by-pass, California State Highway 41 now enters Paso Robles from the East at Ysabel Avenue and U.S. Highway 101 via the new Salinas River bridge; and

WHEREAS, it is necessary for the traveling public on State Highway 41 to enter this City along and over Ysabel and Riverside Avenues and thence Westerly along 26th Street to Spring Street, by way of a railroad grade crossing on 26th Street at the Southern Pacific company right-of-way; and

WHEREAS, the Legislature of the State of California is endeavoring to eliminate all such grade crossings in the interest of safety to the traveling public; and

WHEREAS, this City has entered into a written agreement with the Department of Public Works, Division of Highways, of the State of California, to eliminate the said grade crossing on 26th Street by means of opening 24th Street and constructing a railroad over crossing, and by constructing a new city street to connect with State Highway 41 at Ysabel Avenue and U.S. Highway 101; and

WHEREAS, the City of El Paso De Robles has acquired or is in the process of acquiring all necessary


