

RESOLUTION NO. 1144

A RESOLUTION ESTABLISHING PREVAILING WAGE SCALE  
 RIVERSIDE AVENUE SEWAGE PUMPING STATION  
 AND OUTFALL SEWER  
 13TH STREET SEWER REALIGNMENT

RESOLVED, by the City Council of the City of Paso Robles, California, that

WHEREAS, this Council has ascertained the general prevailing rate of per diem wages in the locality in which public work is proposed to be performed for work of a similar character to that proposed to be done on the Riverside Avenue Sewage Pumping Station and Outfall Sewer and the 13th Street Sewer Realignment;

WHEREAS, this Council has duly considered said scale and finds the same to be correct in all particulars;

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED and ORDERED, that the general prevailing rate of per diem wages in the locality in which public work is proposed to be performed for work of a similar character to that for the construction of the Riverside Avenue Sewage Pumping Station and Outfall Sewer and the 13th Street Sewer Realignment, not less than which shall be paid in the performance of said work, is as follows:

## CARPENTERS:

Health and Welfare - 10¢ per hour.

Pension Fund - 10¢ per hour.

Foreman - Receives not less than 33¢ per hour more than hourly rate of the highest classification over which he has responsibility, except "Pneumatic Nailer".

## CEMENT MASONS:

Health and Welfare - 10¢ per hour.

Foreman - When three or more cement masons are employed on a job, one shall be employed as foreman and shall receive not less than 33¢ per hour more than the highest classification over which he has leadership.

and Holidays.
