

RESOLUTION NO. 1458

DECLARING THE RESULT OF THE GENERAL  
MUNICIPAL ELECTION HELD APRIL 9, 1968

BE IT AND IT IS HEREBY RESOLVED by the City Council of the City of El Paso de Robles, in session at their regular meeting place this 16th day of April, 1968, pursuant to the Elections Code of the State of California, under Sections 22932, 22933 and 22934; and

WHEREAS, a general municipal election was held and conducted in the City of El Paso de Robles, County of San Luis Obispo, State of California, on Tuesday, the 9th day of April, 1968; and

WHEREAS, said election was held and conducted in said City at the time and in the manner provided by law and that there were three voting precincts established for hold/<sup>ing</sup>said election, one of which was designated as Precinct "A" and was comprised of the regular election precincts established for the holding of general County and State elections and known as Paso Robles No.1; Paso Robles No.2; Paso Robles No.3; Paso Robles no.4; and Paso Robles No.5. One of which was designated as Precinct "B" and was comprised of the regular election precincts established for the holding of County and State elections and known as Paso Robles No.6; Paso Robles No.7; Paso Robles No.8; Paso Robles No.10; and Paso Robles No.11. One of which was designated as Precinct "C" and was comprised of the regular election precincts established for the holding of County and State elections and known as Paso Robles No.9; Paso Robles No.12; Paso Robles No.13; Paso Robles No.14; and Paso Robles No.15; and

WHEREAS, the City Council of the City of El Paso de Robles at this meeting having canvassed the returns of said election and found that the number of votes cast in said City, the names of the persons voted for, the office for which each parson was voted for, the votes given at each precinct to each person and the results of said election to be as hereinafter stated:

That the whole number of votes cast in said election was 1,214;
