

RESOLUTION NO. 1501

A RESOLUTION REQUESTING THAT THE COUNTY HEALTH OFFICER OF THE COUNTY OF SAN LUIS OBISPO AND EX-OFFICIO HEALTH OFFICER OF THE CITY OF PASO ROBLES, RECOMMEND PROCEEDINGS UNDER APPROPRIATE SPECIAL ASSESSMENT AND ASSESSMENT BOND ACTS, OR OTHER APPROPRIATE PROCEEDINGS, FOR THE CONSTRUCTION OF A SANITARY SEWERAGE SYSTEM AND APPURTENANCES, AS NECESSARY AS A HEALTH MEASURE

FRESNO STREET SEWER ASSESSMENT DISTRICT

RESOLVED, by the City Council of the City of Paso Robles, California, that

WHEREAS, it is the intention of this Council to undertake proceedings pursuant to appropriate special assessment and assessment bond acts for the acquisition and construction of a sanitary sewerage system in said City, as follows:

(a) The construction of sanitary sewer mains with Y's for sewer house laterals, together with standard manhole and lamphole frames and covers, and all appurtenances thereto, together with connection of said sanitary sewer mains to the facilities of the City, in Fresno Street from Merry Hill Road easterly 1020 feet, more or less, in Ridgeview Drive from Fresno Street northeasterly 100 feet, more or less, and in easements between Lots 13 and 14, 14 and 15, and 16 and 17 of a portion of Block 197, Tract 37.

(b) The acquisition of all lands and easements and the performance of all work auxiliary to any of the above which may be necessary to complete the same. Property owners are to connect their sewer lateral to the sewer main at the time of their need.

WHEREAS, it is the intention of this Council to make the costs and expenses of said acquisition and improvements chargeable upon the properties benefited thereby, the exterior boundaries of the assessment district being the coterminous exterior boundaries of the composite and consolidated area shown on the map thereof on file in the office of the City Clerk.

NOW, THEREFORE, IT IS ORDERED that the request be, and the same is hereby, made of the County Health Officer of the County of San Luis Obispo and ex-officio Health Officer of the City of Paso Robles, that he recommend said proceedings as necessary as a health measure.


