

RESOLUTION NO. 1505

A RESOLUTION DETERMINING TO UNDERTAKE PROCEEDINGS PURSUANT TO APPROPRIATE SPECIAL ASSESSMENT AND ASSESSMENT BOND ACTS OR OTHER APPROPRIATE PROCEEDINGS, FOR THE ACQUISITION AND CONSTRUCTION OF A SANITARY SEWERAGE SYSTEM AND APPURTENANCES WITHOUT PROCEEDINGS UNDER DIVISION 4 OF THE STREETS AND HIGHWAYS CODE

FRESNO STREET SEWER ASSESSMENT DISTRICT

RESOLVED, by the City Council of the City of Paso Robles, California, that

WHEREAS, the County Health Officer of the County of San Luis Obispo and ex-officio Health Officer of the City of Paso Robles, has recommended to this Council as necessary as a health measure, which recommendation was given in writing and signed by him, that it undertake appropriate special assessment and assessment bond proceedings for the acquisition and construction of a sanitary sewerage system in said City, all as more particularly described as follows:

(a) The construction of sanitary sewer mains with Y's for sewer house laterals, together with standard manhole and lamphole frames and covers, and all appurtenances thereto, together with connection of said sanitary sewer mains to the facilities of the City, in Fresno Street from Merry Hill Road easterly 1020 feet, more or less, in Ridgeview Drive from Fresno Street northeasterly 100 feet, more or less, and in easements between Lots 13 and 14, 14 and 15, and 16 and 17 of a portion of Block 197, Tract 37.

(b) The acquisition of all lands and easements and the performance of all work auxiliary to any of the above which may be necessary to complete the same. Property owners are to connect their sewer lateral to the sewer main at the time of their need.

WHEREAS, the cost of said project will be assessed upon the district benefited thereby, the exterior boundaries of which are the coterminous exterior boundaries described on the map thereof on file in the office of the City Clerk to which reference is hereby made for further particulars.

NOW, THEREFORE, IT IS FOUND, DETERMINED and ORDERED, as follows:

1. That a copy of said Health Officer's letter be spread upon the minutes of this meeting.

2. That said proceedings so proposed to be undertaken by this Council for the acquisition and construction of said sanitary sewerage system are necessary as a health measure.

3. That the provisions of Division 4 of the Streets and Highways Code are hereby dispensed with and no longer apply to said proceedings.


