RESOLUTION OF COMMENDATION



WHEREAS, the Army Corps of Engineers, our Representatives in the California Legislature, Donald L. Grunsky and William M. Ketchum, Congressman Burt L. Talcott, and others cooperated most heartily with the Director of Public Works of this City in repairing much of the disaster damage caused by said flooding.


