

RESOLUTION NO. 1845-A

RESOLUTION OF THE CITY OF EL PASO DE ROBLES
ADOPTING THE ANNUAL TRANSPORTATION CLAIM AND THE
ANNUAL PROJECT AND FINANCIAL PLAN FOR FINANCING RIGHT-OF WAY
ACQUISITION AND CONSTRUCTION OF LOCAL STREETS UNDER SB-325

WHEREAS, the Legislature provides for the implementation of State funds, under SB-325; and

WHEREAS, the San Luis Obispo County Planning Department and the State of California require that a Claim be submitted not later than May 17, 1974; and

WHEREAS, the funds are available under the Transportation Development Act of 1971, as provided in the Government Code and the Public Utilities Code, as enacted by SB-325 (1971), and the California Administrative Code; and

WHEREAS, the list of projects are in the 1974-75 fiscal year Street Program adopted by the City of El Paso de Robles City Council; and

WHEREAS, these funded projects will be constructed during this fiscal year; and

WHEREAS, the estimated apportionment amounts to \$32,525.71, being the amount remaining after the deduction of \$291.02 for administrative costs and designation of \$12,006.28 to the Area Council for the purpose of developing the Regional Transportation Plan as required by AB-69; and

WHEREAS, the Claim and all other documents shall be presented to the Area Council.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of El Paso de Robles hereby approves the Annual Project and Financial Plan as required under SB-325, and requests that the City of El Paso de Robles Annual Transportation Claim of 1974-75 fiscal year be approved and presented to the San Luis Obispo County and Cities Area Planning Coordinating Council for approval; and

BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are authorized to execute and submit the Claim and all necessary documents, and that said Annual Transportation Claim and all documents pertinent thereto are hereby approved.


