RESOLUTION NO. 2388

ESTABLISHING FEES FOR THE PRIVILEGE OF BRINGING SOLID WASTE TO THE PASO ROBLES SOLID WASTE DISPOSAL SITE

BE, AND IT IS HEREBY, RESOLVED by the City Council of the City of El Paso de Robles as follows:

- 1. That Resolution No. 1974, dated September 2, 1975, adopting rates for bringing solid waste to the Solid Waste Disposal Site, is hereby rescinded.
- 2. That the rates for bringing solid waste to the Solid Waste Disposal Site are to be charged as follows and are to become effective on and after February 1, 1980.

a. Auto and minimum.....	\$ 1.25
b. Pickup - short bed (level).....	2.50
c. Pickup - short bed (high).....	3.00
d. Pickup - long bed (level).....	3.00
e. Pickup - long bed (high).....	3.50
f. Station wagon.....	2.00
g. Truck - 8' bed X 3' high.....	3.50 minimum
h. Truck - 10 X 3.....	4.50 minimum
i. Truck - 12 X 3.....	5.50 minimum
j. Truck - 14 X 3.....	6.50 minimum
k. Semi-trailer.....	18.00 minimum
l. 2 axle dump.....	8.00 minimum
m. 3 axle dump.....	9.00 minimum
n. Garbage truck (packers & drop boxes).....	.90 cu. yd.
o. Garbage truck (from outside City).....	.95 cu. yd.
p. Hard to handle items (stumps, wire, tires, appliances, etc.).....	To be determined at gate.


