

RESOLUTION NO. 2395

A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF EL PASO DE ROBLES, CALIFORNIA, ESTABLISHING  
VOTING PRECINCTS AND APPOINTING ELECTION OFFICERS  
AND PROVIDING FOR COMPENSATION OF SAID OFFICERS FOR  
A GENERAL MUNICIPAL ELECTION TO BE HELD IN SAID CITY  
ON THE EIGHTH DAY OF APRIL, 1980

WHEREAS, the City Council of the City of El Paso de Robles has called for a general election to be held on the 8th day of April, 1980; and

WHEREAS, it is necessary to appoint election officers and provide for the compensation thereof; and

WHEREAS, it is necessary to establish voting precincts.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY RESOLVE, DECLARE, DETERMINE AS FOLLOWS:

SECTION 1. That for the purpose of holding said regular general municipal election, there shall be and are hereby established four (4) voting precincts consisting of consolidations of the regular election precincts in the City of El Paso de Robles established for the holding of state and county elections, as said regular election precincts exist on the date of adoption of this resolution. That the polling places for the respective precincts shall be the places hereinafter designated; and that the persons hereinafter named, being competent and qualified electors and residents of said City and of their respective voting precincts, are hereby appointed officers of election for their respective voting precincts and they shall hold said election and make return thereof in the manner provided by law.

SECTION 3. That in all particulars not recited in this Resolution, said election shall be held and conducted as provided by law for holding municipal elections in said City.

SECTION 4. That the City Clerk shall certify to the passage and adoption of this Resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minute of the passage and adoption thereof in the records of the proceedings of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.

SECTION 5. That this Resolution shall take effect immediately.




