

RESOLUTION NO. 2396
A RESOLUTION OF INTENTION FOR
CLOSING A STREET IN THE CITY OF EL PASO DE ROBLES AND
GIVING NOTICE OF TIME AND PLACE FOR A PUBLIC HEARING THEREON

The CITY COUNCIL of the CITY OF EL PASO DE ROBLES
does hereby resolve as follows:

1. That it is the intention of the City Council to close and vacate a public street in the City of El Paso de Robles, County of San Luis Obispo, State of California, and more particularly described as follows:

The City of El Paso de Robles proposes to abandon a Public Utilities Easement in the City of El Paso de Robles, more particularly described as follows:
The Southerly 10 feet of Block 2, Tract 276 as recorded in Volume 6, Page 91 in the Office of the County Recorder of the County of San Luis Obispo.

2. For further particulars as to the proposed vacation, reference is hereby made to a map and plan now on file in the Office of the City Clerk of the City of El Paso de Robles.

3. That March 18 1980, at the hour of 7:30 p.m., on said date in the City Council Chambers, City Hall, 1030 Spring Street, Paso Robles, California, is the time and place set forth for hearing all persons interested in or having objections to the proposed closing.

4. That the City Clerk of the City of El Paso de Robles be and is hereby directed to cause a copy of this Resolution of Intention to be published fifteen (15) days prior to the date set herein for hearing in the Paso Robles Daily Press, a newspaper of general circulation, published and circulated in the City of El Paso de Robles, California.

5. The Director of Public Works of the City of El Paso de Robles be and is hereby directed to cause a notice of the passage of this Resolution of Intention and the time and place set for hearing thereon by conspicuously posting notices thereof along the line of the street proposed to be closed.


