

RESOLUTION NO. 2398

A RESOLUTION OF INTENTION
FOR CLOSING A PORTION OF AN EASEMENT IN THE
CITY OF EL PASO DE ROBLES

The CITY COUNCIL of the CITY OF EL PASO DE ROBLES does hereby resolve as follows:

1. That it is the intention of the City Council to close and vacate a portion of a Public Utility Easement in the City of El Paso de Robles, County of San Luis Obispo, State of California, and more particularly described as follows:

The northerly five feet (5') of the fifty foot (50') easement as shown on the Map recorded in Book 23, at Page 21 of Parcel Maps, designated PR-77-163 Sherwood Industrial Park, on file in the Office of the County Recorder of San Luis Obispo County, State of California.

2. For further particulars as to the proposed vacation, reference is hereby made to a map now on file in the Office of the City Clerk of the City of El Paso de Robles.

3. That April 1, 1980, at the hour of 7:30, on said date in the City Council Chambers, City Hall, 1030 Spring Street, Paso Robles, California, is the time and place set forth for hearing all persons interested in or having objections to the proposed closing.

4. That the City Clerk of the City of El Paso de Robles be and is hereby directed to cause a copy of this Resolution of Intention to be published fifteen (15) days prior to the date set herein for hearing in the Paso Robles Daily Press, a newspaper of general circulation, published and circulated in the City of El Paso de Robles, California.

5. The Director of Public Works of the City of El Paso de Robles be and he is hereby directed to cause a notice of the passage of this Resolution of Intention and


the time and place set for hearing thereon by conspicuously posting notices thereof along the line of the easement proposed to be closed.


