

RESOLUTION NO. 2403

A RESOLUTION APPROVING ANNEXATION NO. 41 (CHANDLER)

WHEREAS, the Local Agency Formation Commission has by its Resolution No. 79-16 recommended the annexation of contiguous territory known as Annexation No. 41 (Chandler) to the City of El Paso de Robles subject to the following conditions and terms:

1. That written assurance be given that the developer will finance and construct the extension of Airport Road across his property, to be received by the City prior to the date of the City's hearing on the annexation.
2. That the City of Paso Robles is authorized to complete the annexation without further notice, hearing or election.

WHEREAS, said territory as legally described and certified to the city by LAFCO is described on Exhibit "A" and "B", a legal description and a map, both of which are attached hereto; and

WHEREAS, an Environmental Impact Report, attached hereto as Exhibit "C", was prepared giving various mitigating measures to the proposal to annex said territory and said report having been considered by the City Planning Commission and City Council was certified as being adequate contingent upon mitigating measures; and

WHEREAS, the City Council of the City of El Paso de Robles, after considering all of the above and the proponent for the annexation having formally requested that the annexation proceed after submitting written

consent that the area to be annexed shall be taxed to pay its proportional share of the bonded indebtedness of the City of El Paso de Robles.


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of El Paso de Robles that Annexation No. 41 (Chandler) be annexed to the incorporated area of said city subject to the execution of an agreement setting forth certain impacts and agreeing to payment of impact fees, said agreement attached hereto as Exhibit "D".


