RESOLUTION NO. 2406

A RESOLUTION CLOSING A PORTION
OF AN EASEMENT IN THE CITY OF
EL PASO DE ROBLES

WHEREAS, the City Council of the City of El Paso de Robles, having on the 4th day of March, 1980, passed a Resolution of Intention to close and vacate a portion of an easement in the City of El Paso de Robles, County of San Luis Obispo, State of California, and more particularly described as follows:

The northerly five feet (5') of the fifty foot (50') easement as shown on the Map recorded in Book 23, at Page 21 of Parcel Maps, designated PR-77-163 Sherwood Industrial Park, on file in the Office of the County Recorder of San Luis Obispo, State of California.

WHEREAS, it now appears that the City Clerk of the City of El Paso de Robles did cause said Resolution of Intention to be published in the Paso Robles Daily Press as required by law; and

WHEREAS, it further appears that said notices and publications were in all respects as required by the provisions of an act of the Legislature of the State of California entitled "Street Vacation Act of 1941," Division IX, Part 3, Chapters 1 and 2 of the Streets and Highways Code; and


WHEREAS, a public hearing has been held on said proposed closing as so noticed and having heard all evidence offered by any person interested, the City

Council of the City of El Paso de Robles finds that the portion of easement as described is unnecessary for present or prospective future public utility purposes.

THEREFORE, BE IT RESOLVED, that a portion of the public utility easement cease on said easement hereinbefore described and be vacated for public utilities.




