

RESOLUTION NO. 2429

A RESOLUTION DESCRIBING PROPOSED BOUNDARIES OF
ASSESSMENT DISTRICT, DIRECTING FILING OF MAP
AND DIRECTING RECORDATION OF NOTICE OF ASSESSMENT

CRESTON/NIBLICK ASSESSMENT DISTRICT 79-2

RESOLVED, by the City Council of the City of El Paso de
Robles, California, that

WHEREAS, this Council proposed to undertake proceedings
for the formation of an assessment district pursuant to Peti-
tions on file with the City Clerk.

NOW, THEREFORE, IT IS ORDERED, as follows:

1. The proposed boundaries of said assessment district to
be assessed in said proceedings, are hereby described as shown
on a map of said assessment district on file in the office of
the City Clerk, which shows the lots, pieces or parcels of land
proposed to be assessed and which indicates by a boundary line
the extent of the territory included in the proposed assessment
district and which shall govern for all details as to the extent
of such district, reference to such map being hereby made for
particulars. Said map contains the name of the City and dis-
tinctive designation in words or by number of the district shown
thereon.

2. On the original and at least one copy of said map the
City Clerk shall endorse his certificate evidencing the date and
adoption of this resolution. The City Clerk shall file the
original of such map in the office and, within fifteen (15) days
after adoption of the Resolution fixing time and place of hearing
on the formation or extent of said district, and in no event
later than fifteen (15) days prior to such hearing, shall file
a copy thereof with the County Recorder of the County of San
Luis Obispo in which all of such proposed assessment district is
located.

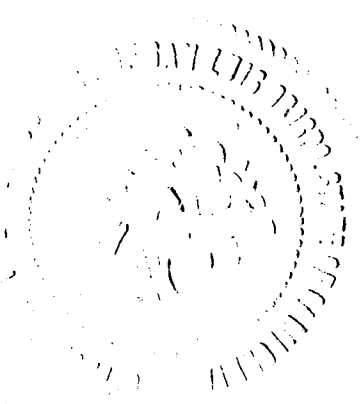
