

RESOLUTION NO. 2431

A RESOLUTION CALLING FOR SEALED PROPOSALS

DOWNTOWN PARKING ASSESSMENT DISTRICT

RESOLVED, by the City Council of the City of El Paso de Robles, California, that

WHEREAS, the Council of the City of El Paso de Robles did, on the 2nd day of October, 1979, adopt its Resolution of Intention No. 2352, to acquire and construct improvements to standards required by the City of El Paso de Robles, County of San Luis Obispo, all as more particularly described and set forth in said Resolution of Intention.

NOW, THEREFORE, the City Clerk is hereby directed to publish once a week for two weeks in the local newspaper published and circulated in said City, a notice inviting sealed proposals or bids for the construction of said improvements, and referring to the plans and specifications on file in the office of said Clerk, the first publication of which notice shall be at least fourteen (14) days prior to the time fixed for opening bids.

All proposals or bids shall be accompanied by a cashier's or certified check payable to the order of the City amounting to ten percent (10%) of the bids, or by a bond in said amount and payable to said City signed by the bidder and a corporate surety or by the bidder and two sureties who shall justify before any officer competent to administer an oath, in double said amount and over and above all statutory exemptions. Said check shall be forfeited or said bond shall become payable to said City in case the bidder depositing the same does not, within fifteen (15) days after written notice that the contract has been awarded to him enter into a contract with the City.

Said sealed proposals or bids shall be delivered to the City Clerk on or before 2:00 o'clock p.m., on the 16th day of July, 1980, said time being not less than

fourteen (14) days from the time of the first publication of said notice. Bids will be publicly opened, examined and declared on said day and hour.


