

RESOLUTION NO. 2444

A RESOLUTION OVERRULING PROTESTS ON
RESOLUTION OF INTENTION TO ACQUIRE
AND CONSTRUCT IMPROVEMENTS

CRESTON/NIBLICK ASSESSMENT DISTRICT 79-2

RESOLVED, by the City Council of the City of El Paso de Robles, County of San Luis Obispo, California, that

WHEREAS, this Council did on the 17th day of July, 1979, adopt its Resolution of Intention No. 2322, to acquire and construct public improvements in and for said City; and

WHEREAS, on June 7, 1980, this Council adopted Resolution No. 2428 appointing time and place of hearing protests in relation to the proposed acquisitions and improvements and directing notice:

WHEREAS, notice was given of the time and place therein stated in the manner provided by law, as appears from the affidavits on file in the office of the City Clerk; and

WHEREAS, said matter came on regularly for hearing at the time therein fixed; and

WHEREAS, all written protests and other written communications were publicly read at said meeting and all persons desiring to be heard were fully heard.

NOW, THEREFORE, IT IS ORDERED, as follows:

1. That protests against said acquisitions and improvements were not signed by the owners of a majority or more of the area of the lands within the assessment district, or of the area of the lands within the assessment district assessed for the costs and expenses of said work.

2. That said protests be, and each of them are hereby, overruled.


