RESOLUTION NO. 2464

A RESOLUTION APPROVING ANNEXATION NO. 35

WHEREAS, a petition for annexation of the hereinafter described property has been filed; and

WHEREAS, the petition has been signed by the owners of all of the land in the territory, and no protests may be filed against the annexation by persons owning property in the territory; and

WHEREAS, no protests have been filed against the annexation; and

WHEREAS, the Local Agency Formation Commission under Resolution 78-9 approved Annexation No. 35 subject to the following terms and conditions:

1. That property be rezoned prior to completion of the annexation to the city.
2. That the city be authorized to complete the annexation without further notice, hearing or election.
3. That the portions of Merryhill Road adjacent to the proposed annexation be included in the annexation; being the total of Merryhill Road to the point where it joins Peachy Canyon Road, with map and legal description to be certified by the County Surveyor and LAFCO.

WHEREAS, pursuant to Section 65859 of the Government Code of the State of California, annexation has been rezoned.

NOW, THEREFORE, BE IT RESOLVED that the annexation of territory hereinafter described and designated "Annexation No. 35" under the Annexation of Uninhabited Territory Act of 1939 comprising Government Code Section 35300-35326 is approved subject to written consent by the owners of said annexation area to be taxed to pay his proportional share of the bonded indebtedness of the City of El Paso de Robles.

RESOLVED FURTHER, the property annexed to the City of El Paso de Robles is more particularly described in Exhibit "A" attached hereto and made a part hereof by this reference.

RESOLVED FURTHER, that the City Clerk is directed to transmit a certified copy of this resolution to the Executive Officer of the Local Agency Formation Commission together with fees required by Section 54902.5 of the Government Code of the State of California and any other attachments germane.


