

RESOLUTION NO. 2466

RESOLUTION OF THE REDEVELOPMENT AGENCY OF
THE CITY OF EL PASO DE ROBLES, CALIFORNIA,
DIRECTING STAFF TO PROCEED WITH PREPARATION
OF THE REDEVELOPMENT PLAN AND TO UNDERTAKE
AN ENVIRONMENTAL EVALUATION OF SAID PLAN
AND PROJECT AREA

WHEREAS, this Redevelopment Agency has received and considered the Project Area Map and Preliminary Plan for Redevelopment Project Area No. 1 from the Planning Commission; and

WHEREAS, this Redevelopment Agency intends to proceed with preparation of the redevelopment plan required pursuant to the provisions of the "Community Redevelopment Law" (commencing with Section 33000 of the Health and Safety Code) and to undertake an environmental evaluation of said plan and Project Area No. 1 pursuant to the provisions of the "California Environmental Quality Act" (commencing with Section 21000 of the Public Resources Code):

NOW, THEREFORE, the Redevelopment Agency of the City of El Paso de Robles does hereby RESOLVE, DETERMINE AND ORDER as follows:

Section 1. That the above recitals are all true and correct.

Section 2. That the staff is hereby authorized and directed to proceed with preparation of the redevelopment plan for Project Area No. 1 and to undertake an environmental evaluation of said plan and Project Area No. 1.

Section 3. That staff is further directed to return said redevelopment plan and environmental evaluation as soon as possible for consideration and review by this Redevelopment

Agency.


