

RESOLUTION NO. 2472

RESOLUTION OF THE REDEVELOPMENT AGENCY OF  
THE CITY OF EL PASO DE ROBLES, CALIFORNIA,  
ADOPTING PROCEDURES AND GUIDELINES FOR  
IMPLEMENTATION OF THE CALIFORNIA ENVIRON-  
MENTAL QUALITY ACT, AS AMENDED.

WHEREAS, the "California Environmental Quality Act", commencing with Section 21000 of the Public Resources Code requires that projects undertaken by public agencies shall be subject to an environmental evaluation as early as possible in the planning process; and

WHEREAS, pursuant to Section 21082 of the Public Resources Code, all public agencies are required to adopt procedures and guidelines for the environmental evaluation of projects, pursuant to the provisions of the California Environmental Quality Act, as amended:

NOW, THEREFORE, the Redevelopment Agency of the City of El Paso de Robles does hereby RESOLVE, DETERMINE AND ORDER as follows:


Section 1. That the above recitals are all true and correct.




